THAT for and in consideration of the sum of ONE (\$1.00) DOLLAR, cash in hand paid, and the further consideration that the Grantee herein will pay the burial expenses, debts and taxes owed by Robert Mc Kee at the time of his death, in the principal sum of TWO THOUSAND (\$2,000.00) DOLLARS, and the further consideration that the Grantee herein does hereby agree to and fully assumes and agrees to pay, according to its terms and tenor, the balance due on the mortgage given by the decedent-Robert McKee, on March 11, 1972 to the First City Bank and Trust Company of Hopkinsville, Kentucky on the real estate herein conveyed, said mortgage to said bank being in the original sum of THREE THOUSAND (\$3,000.00) DOLLARS, and same is now of record in Mortgage Book 268, page 519, Christian County Court Clerk's

Office, said mortgage and accrued interest thereon now being in the balance of THREE THOUSAND (\$3,000.00) DOLLARS, and it being hereby provided that a proper release of said mortgage shall operate as a full and complete release of any claim against the Grantors herein, and now they, the said Grantors herein, do hereby bargain, sell and convey unto the Grantee, in fee simple, the following described real property, located in Christian County, Kentucky, to-wit:

TRACT I

(Third Tract) A certain tract or parcel of land lying and being in the Northeastern part of Christian County, Kentucky, on the headwaters of Little River and bounded as follows: Being the Northwardly part of a 21-acre tract conveyed by Hunter Wood, Commissioner, to H.R. Vaughn:
